

BOBSLEIGH AND SLEDGE TRACK "SIGULDA"  
SUMMER BOBSLEIGH  
USER AGREEMENT TERMS

1. GENERAL RULES

1.1. This BOBSLEIGH AND SLEDGE TRACK "SIGULDA" SUMMER BOBSLED USER AGREEMENT (hereinafter – the "Agreement") determines the use of the bobsleigh and sledge track "Sigulda" and the territory adjacent to it, as well as defining the rights and obligations of its users. The "Sigulda" bobsleigh and sledge track territory consists of a concrete surface downhill specifically designed for summer bobsled runs accompanied by a professional pilot (BST "Sigulda" pilot) and the adjacent road (hereinafter – the "Track").

1.2. The legal relationship between the user of the Track (hereinafter - the "User") "Bobsleigh and sledge track "Sigulda"" (hereinafter - "BST") is determined by this contract. BST is a unit of SIA "Latvijas Nacionālais sporta centrs". This contract is concluded when a person purchases either a ticket, a gift card or otherwise legally obtains the Owner's permission or approval to use the Track for a summer bobsleigh ride (hereinafter - the "Ticket").

1.3. BST authorizes the User to use the Track only for summer bobsleigh riding in accordance with this Agreement.

1.4. Only persons who own a Ticket may use the Track. A person who has not received BST's permission to use the Track or who does not possess a Ticket has no right to use the Track.

1.5. The terms of this Agreement are not recognized as an offer by BST. The individual's act of purchase of a Ticket from BST or its authorized person is recognized as an offer to conclude this Agreement. BST's or its authorized person's issuance of a Ticket to the individual or permission to use the Track is recognized as an acceptance of the Agreement's conclusion. BST or its authorized person is not obliged to accept the offer. The terms and conditions of this Agreement, as well as any other circumstances, cannot be recognized as a guarantee or assurance that the offer made by the individual is accepted.

1.6. The User's obligations and BST's rights defined in this Agreement are binding and also apply to those persons who actually use the Track without a Ticket or before purchasing a Ticket or after its expiration. The use of the Track is recognized as the fact that the individual has accepted the terms of this Agreement and recognized them as binding.

1.7. Only a person who is at least 6 years old has the right to use the Track. A person, who has not reached the age of 6, has a right to use the Track only if accompanied by an adult.

1.8. Dogs and other animals are prohibited on the Track in all cases, regardless of whether they are on a leash or have muzzles.

1.9. It is forbidden to stay or move on the driving part of the Track.

1.10. It is forbidden to throw any objects on the Track, or to perform actions indirectly related to the descent while using the Track, such as intentionally disturbing the pilot, swinging the summer bob during the ride, etc.

1.11. It is forbidden to ride a bicycle on the Track or on the adjacent road of the Track, during summer bobsleigh races.

## 2. TERM OF AGREEMENT

2.1. At the moment an individual purchases a Ticket or receives the Owner's permission to use the Track, the individual is considered a "User" within this Agreement and is bound by it and its obligations.

2.2. The User has the right to use the Track only during the term of this Agreement.

2.3. The term of the contract expires, and thus the right to use the Track, if the time specified in the Ticket expires or if all the number of descents allowed in the Ticket have been used.

2.4. The term of the Agreement expires, and with it the right to use the Track, if a person's Ticket is cancelled due to non-compliance with the clauses of this Agreement.

## 3. SUMMER BOBSLEIGH

3.1. This Agreement entitles the User to use the Track for downhill riding only with a specifically designed summer bobsleigh provided by BST.

3.2. It is forbidden to use any other objects or devices on the Track, or to move or be on the driving part of the Track.

## 4. USER OBLIGATIONS

4.1. The user is obliged to comply with the provisions of this Agreement, and any signs or instructions on the Track. The User is obliged to comply with the requirements or instructions of BST employees, who are appropriately dressed or otherwise marked with a relevant distinguishing mark (hereinafter - "Track personnel"), regarding the Track and its use.

4.2. Users are prohibited from using the Track if under the influence of alcohol, narcotics or psychotropic substances.

4.3. It is forbidden for the User to walk on the driving part of the Track or to disturb or endanger other users of the Track in any way.

4.4. The User is prohibited from standing on the driving part of the Track, on the concrete board side of the Track or on the technical Track.

4.5. The User is fully responsible for their own health and life on the Track and is responsible for following the instructions given by the Track staff before the trip, as well as the instructions given by the pilot before or during the trip and not endangering other Track Users.

4.6. The user waives any right of claim and undertakes not to raise any property or other claims or demands against BST for personal injury, damage or loss (injuries, damage to clothing, camera and other objects) incurred on the Track, which occurred due to the fact that the User or third parties did not comply with the BOBSLEIGH AND SLEDGE TRACK "SIGULDA" SUMMER BOBSLEIGH USER AGREEMENT TERMS or did not obey the instructions of BST "Sigulda" employees.

## 5. DESCENT RULES

5.1. A user about to start their descent must check their clothes and pockets to make sure that no objects (phone, wallet, keys, etc.) can fall out of them or otherwise endanger a safe descent.

5.2. The User must familiarize himself or herself with the terms of this Agreement before starting the trip. The user may not enter the summer bobsleigh before the Track staff has instructed them and given permission.

5.3. During the descent, the User must hold on to the handles of the summer bobsleigh. During the descent, it is forbidden to pull the summer bobsleigh or the protective grid, as it may disturb the pilot. During the descent, the User is forbidden to touch the driving part of the Track (including the concrete sides) or to put his/her hands outside the summer bobsleigh.

5.4. At the finish, the pilot reverses the summer bobsleigh from the driving part of the Track. At the finish line, the summer bobsleigh is met by an employee of the Track, and after hooking it to the vehicle (the User remains seated in the summer bobsleigh), it is lifted up to the starting point along the Track access road.

## 6. USER RESPONSIBILITY

6.1. The user is responsible for damage and losses caused to third parties or BST while using the Track.

6.2. In case the User does not comply with the requirements of this Agreement, the Track staff have the right to cancel the User's Ticket and prohibit the User's use of the Track.

6.3. The User is responsible for all damage or losses caused to third parties or the Owner due to non-compliance with the rules of use of the summer bobsleigh, the drivable part of the Track, the take-off vehicle or the summer bobsleigh itself.

6.4. In the case of loss of a ticket, the User has no right to renew it.

6.5. The User does not have the right to request the exchange of the Ticket for money if the User is not satisfied with the Track or the weather conditions.

## 7. LIABILITY OF BST

7.1. BST is not responsible for any accidents or damage caused by violations of the terms of this Agreement.

7.2. BST is not responsible for any damage or theft from vehicles or other personal belongings.

7.3. BST is not responsible for any damage or losses caused due to the improper use of the lift or non-compliance with safety regulations.

## 8. SPECIAL TERMS

8.1. The parties agree that BST may take or authorize third parties to take photos, videos or other sound or visual information recordings of the User and save the information regarding the User in text, sound or visual media data carriers.

8.2. Information processing includes the right to collect, register, enter, store, organize, transform, use, transfer, transmit or delete information. BST may transfer the mentioned information to companies related to BST, as well as to other third parties. The user confirms his/her consent to BST's right to process information or transfer information to third parties. Copyright, distribution rights or other property rights regarding the taken photos, recordings or other obtained information belong to the Owner.
